#### LB626 Nebraska Heartbeat Act is in Jeopardy

In an unexpected turn of events this week, Senator Merv Riepe of District 12, a co-sponsor of LB626, the Nebraska Heartbeat Act, filed an amendment that would allow abortions up to 12 weeks of gestation and allow abortion of babies who are diagnosed with a fetal anomaly.

**The Nebraska Heartbeat Act could stop 85% of abortions in our state and save 2,000 lives every year!** In comparison, Sen. Riepe's amendment would only protect the lives of around 300 babies per year, as that number of abortions are performed in Nebraska after 12 weeks.

The Nebraska Heartbeat Act would require an ultrasound be performed before an abortion to listen for a baby's heartbeat. If a heartbeat is detected, an abortion may not be performed. The Act allows exceptions for rape, incest, or in the event of a medical emergency.

Until Wednesday, March 15<sup>th</sup>, 2023, we had exactly the 33 votes needed to pass LB 626, the life-saving Nebraska Heartbeat Act. Senator Joni Albrecht, sponsor of the bill, expressed surprise and disappointment by Senator Riepe's amendment, saying the loss of his vote for cloture could put LB 626 at risk of falling to a filibuster from abortion rights advocates.

Senator Riepe, a former hospital executive, completed the 2022 Nebraska Right to Life Voter Guide stating he *is in favor of protecting preborn babies from conception, with no exceptions.* He also is on the Health and Human Services Committee and voted to advance LB626 from committee to the full Legislature after sitting through 7 *full hours of of testimony for and against LB626.* He has not confirmed that he would vote for LB626 if his amendment fails.

Dear Senator Riepe,

My name is [INSERT NAME], and I live in [INSERT CITY]. I am writing to urge you to support LB 626, withdraw your amendment to LB 626, and vote in support of the bill as written.

- LB 626, as introduced, will put an end to 85% of abortions in Nebraska. Your amendment would strip away heartbeat protections for 1,700 preborn babies every year.
- We must protect preborn children with their own beating hearts. Every innocent human life deserves protection, especially preborn babies with a detectable heartbeat. A heartbeat is a universal sign of life.
- LB 626, as written, already has support from a large majority of the Nebraska Legislature and Governor Pillen.
- Your amendment could jeopardize this year's pro-life bill altogether. This would leave Nebraska's current 20-week abortion law in place for at least another year and make Nebraska a "destination state" for out-of-state women seeking a late-term abortion.
- Nebraska is a pro-life state. A recent statewide poll revealed that 58% of Nebraskans support a bill protecting preborn babies once a heartbeat is detected.
- There is no question, scientifically or medically, that an unborn child in the womb is a distinct, individual human being with their own DNA and their own heartbeat.

Please support LB 626 and withdraw your amendment. Thank you for your time and consideration.

#### Eighteenth Anniversary of Terri Schiavo's Death: March 31, 2023

When Terri Schiavo collapsed with a cardiac arrest in 1990, she could have had no idea that 33 years later people all over the world would know her name and care very much about the manner in which she died. What began as a private family tragedy ultimately exploded into an international cultural conflagration and what was perhaps the most important legal case involving American bioethics since Roe v Wade. When it was over, Terri was dead, society was bitterly divided, and our culture changed fundamentally.

During the Terri Schiavo trial, bioethicists and others claimed that Terri's death would be gentle. These advocates either intentionally or ignorantly conflated two different circumstances.

- 1. The first, taking food and water from someone whose body readily assimilated sustenance. That is an agonizing death.
- 2. The second, people dying naturally whose bodies are shutting down. In such circumstances, people stop eating and drinking on their own as part of the process of passing on. That does not cause suffering, and indeed, it is medically inappropriate and can be cruel to force sustenance into their bodies.

Terri was a number 1, and the advocates pretended she was a number 2.

Terri's brother, Bobby Schindler, frankly discussed the terrible circumstances of his sister's slow death by dehydration:

These are the hard facts my family and I will have to live with for the rest of my life. After almost two weeks without food or water, my sister's lips were horribly cracked, to the point where they were blistering. Her skin became jaundiced with areas that turned different shades of blue.

Her skin became markedly dehydrated from the lack of water. Terri's breathing became rapid and uncontrollable, as if she was outside sprinting.

Her moaning, at times, was raucous, which indicated to us the insufferable pain she was experiencing. Terri's face became skeletal, with blood pooling in her deeply sunken eyes and her teeth protruding forward.

Even as I write this, I can never properly describe the nightmare of having to watch my sister have to die this way. What will be forever seared in my memory is the look of utter horror on my sister's face when my family visited her just after she died.

It was not long ago that even the thought of deliberately starving and dehydrating brain injured people to death by the denial of food and water would be unconscionable and considered a criminal act.

Here in the U.S., there are 10 states and Washington, DC that have doctor assisted suicide laws after Oregon became the first state to legalize it in 1994. However, what often gets overlooked is that assisted suicide is only one of the arsenals in the culture-of-death toolchest that is used to end the lives of those who are medically vulnerable – either physically or mentally.

If you have been paying attention to this issue and the expanding number of changes in the laws and the policies in healthcare, then you are quite familiar with how susceptible patients are to being denied their autonomy, resulting in their medical care being withdrawn.

The administration of food and water via feeding tubes used to be recognized as ordinary care. Today, it has been redefined as medical treatment and now it is legal in all 50 states to have this most basic right either denied or withdrawn.

There are basic but critically important ways you and your family can protect yourselves. A good start is to make certain you have a trusted pro-life doctor who recognizes our God given human dignity and acts accordingly towards you and your family. Perhaps more importantly, however, is appointing a health care agent in a healthcare durable power of attorney.

it has become clear that medical decisions have shifted from patients and family members to outsiders – effectively strangers – when patients have not legally appointed a health care agent prior to a medical crisis.

In this intensifying secularized world, the respect for the sacredness of life, traditional family values, and common decency are collapsing, and it is now our responsibility to safeguard ourselves and defend our loved ones. There may be a situation where you will have to confront this medical apparatus and literally fight for your life, your children's lives, or another family member's life.

Perhaps the best way to end these remarks is to quote from pro-life President George W. Bush who worked hard on behalf of the Schindler family: "The essence of civilization," he said, "is that the strong have a duty to protect the weak."

#### Science continues to show us the amazing progress of fetal development:

- By **21 days**, a baby's heart begins to beat and the brain, spinal cord, and nervous system are formed.
- By **8 weeks**, she has every organ present.
- At 10 weeks, fingernails begin to develop and
- By 12 weeks she can swallow, make facial expressions, and even smile.
- 85% of abortions in Nebraska are performed within these first 12 weeks!

### With chemical / medication abortions, life-threatening pregnancy complications may go undetected.

- You need to verify there is a <u>heartbeat</u> (miscarriage)
- You need an ultrasound to <u>date</u> the pregnancy Before 10 weeks: chemical abortions are done After 10 weeks: surgical abortions are done
- You need an ultrasound to verify the <u>location</u> of the pregnancy (ectopic)


In 2011, Nebraska enacted a <u>Ban on Webcam Abortions</u>, which states that every abortion, whether chemical or surgical, must be done by a licensed physician physically present in the same room as the pregnant woman. This prevents chemical abortion drugs from being sold at Walgreens / CVS / RiteAid in Nebraska, even though it is legal according to the FDA. Unfortunately, we are not always going to know if the drugs are coming into our state under the radar. *Chemical Abortions account for 54% of all the abortions in the U.S.* according to the Guttmacher Institute.


#### The Final Judgement: Did You Try?
